DEVELOPMENTAL TRAINING OFFERS CHANCE TO LEARN NEW SKILLS & ACHIEVE DREAMS:

Although Leah was born with Down syndrome, she has never let this be a barrier to achieving her dreams of having a job and living independently. Leah's family believed and supported her dreams of independence. After graduating from high school, she moved to her own place, a 16-bed group home in Ottawa. This gave her the opportunity to learn the skills she needed such as meal planning and preparation, laundry and housekeeping skills.

During the first years of attending the Developmental Training program at Ottawa Friendship House, Leah worked each day on pre-vocational training, social skills, and life skills. As she developed these new skills, Leah moved closer to moving to her own home and gaining independence.



her dream of having a place of her own cannot happen without the necessary finances that would come from a job. During the past five years, Leah has been working at the workshop within the agency. She has developed the job

skills and work attitudes that would make her a great candidate for employment. She is mindful of the procedures and policies that guide the workplace. As an elected member of the Advisory Council, she was instrumented in rewriting the consumer handbook that outlines good work practices.

true desire to work in the community and increase her earning potential. Leah is a people person and would love a job that she could have the opportunity to interact with people in the community.

Leah's case manager reviewed her progress in her pre-vocational skills and saw that she would be a great candidate for community employment and referred her to Department of Rehabilitation Services (DORS). Her case manager helped her complete and submit the necessary paperwork so that her case could be opened with DORS. The employment specialist and the DORS case manager met with Leah to determine her skill sets and what kind of employment she would like to seek.

After the initial meeting with DORS, the employment specialist met with Leah and discussed the new community jobs that would be available at Goodwill. The job paid minimum wage, and she would work

during the day, 7 hours each work week. Transportation would not be a problem since the NCAT operated during this time frame. Leah thought that this would be perfect place for her to work! Together with her case manager, she completed the application and hoped that she would be called for an interview.

Leah got that call that she was waiting for and interviewed for the position. She was notified a week later that she had gotten the job. During her first 15 days of employment, Leah attended orientation classes and worked with a job coach so she could learn the skills necessary for her job. Leah then sailed through her 90 days of employment with no concerns from her job coach.

When asked what Leah likes best about her job -other than a paycheck -- she will flash you a great smile and say, "the employee discount!"

HOW TO HELP: Funding is an important component to the success of Ottawa Friendship House. In late 2012, the agency's Board of Directors passed a resolution establishing an endowment program called "BOBS Friends," honoring the late brother of the program's initial donor and creator.

An endowment is a restricted fund which preserves the capital. Only the interest from the fund can be spent, not the principal that anchors the endowment. Typically, the interest or annual earnings from the endowment (usually 5%) are spent each year. The remainder is left to help the fund grow over time and to assure it can produce more while allowing the fund to keep pace with inflation.

BOBS Friends will fund future needs of the agency and provide comfort to donors, knowing that Ottawa Friendship House will continue to grow well into the future.

Donors who make arrangements for a future gift will be recognized and honored through the provisions of the endowment program. Contributions may be made in one or more of the following ways:

- Making an outright gift of money, securities, property or other marketable assets
- Creating a charitable remainder trust or life estate gift to benefit Ottawa Friendship House
- Naming Ottawa Friendship House as a beneficiary of a new or existing life insurance policy
- Naming Ottawa Friendship House to receive a bequest in a will or living trust
